



## **2020 Membership Programs - Fall Incentive**

*All prices are subject to all applicable tax and are subject to change after May 1, 2020. All programs are subject to the applicant joining for 2020. All qualified applicants will not be responsible for any special levies in 2019 or 2020. Applicants in the Senior category may start playing as soon as September 1, 2019 by making a non refundable deposit of \$1500 (\$2000/couple) on the 2021 dues. There are no play restrictions to this program.*
