### **Program #1**

The fee below is for the 2018 season only, and applicants will not be responsible for operating assessments. No play restrictions. Full access to all amenities.

## **Program #2**

A 1 year program in 2018, allowing play to after 2 p.m. only. \$3750 per person, \$5500 per couple. No assessments apply in 2018. House minimum \$400 per person. Full access to all amenities after 12 p.m.

## **Program #3**

For 2018, restricted play option for Mondays, Wednesday, Thursday, and Saturdays after 2 p.m.. \$2500 per person. No assessments. Minimum F&B \$400. Our corporate tournaments will take precedence. Access to all amenities after 12 the day of play only.

## **Program #4**

Corporate member program - \$5000 buy in for life, \$5000 for 60 golf passes. Only restriction is after 12 p.m. on weekends. \$1500 F&B minimum per corporation. No assessments. Full access at time of play.

## **Program #5**

Special 2 day membership for 2018. Play Thursday and Saturday only after 2 p.m. for only \$1750. No minimum, no assessments. Full access after 12 p.m. on day of play. Paid guests only permitted

## **Program #6**

Social/cycling category, \$1000 per person, \$1500 per couple, \$300 per child (as part of a family), full social benefits (pool, locker and practice areas). Any assessments or house minimums do not apply.

## **Program #7**

For 2018, a restricted membership for Thursdays only after 2 p.m. \$800. No minimums no assessments. Access to amenities after 12 p.m. on day of play.
